**THE FOLLOWING ARE EXCERPTS FROM THE**  
**CITY ORDINANCES GOVERNING**  
**GARAGE SALE:**

- **Hours of sale shall be between 9:00 A.M. and 5:00 P.M. only.**
- **Only two (2) permits per calendar year may be issued to any one applicant at one location.**
- **Sale shall be authorized only for day applied for on the application with the following day being authorized as a rain date.**
- **No items of merchandise may be displayed on the street, front sidewalk, or between the front sidewalk and curb of the street.**
- **Merchandise may be displayed in the front yard, driveway, or rear yard, but not beyond ten (10) feet from the face of the dwelling house.**
- **Permit must be displayed prominently.**
- **Signs advertising sale are authorized to be displayed on the day of the sale during the hours permitted at the premise for which the permit is issued.**
- **All signs must be removed from the premise immediately upon conclusion of the sale.**
