AN ORDINANCE TO AMEND ORDINANCE NO. 4566
CODIFIED IN CHAPTER 2.100 OF THE CODE OF THE CITY
OF ELIZABETH ENTITLED "FEES FOR MUNICIPAL
RECORDS," SPECIFICALLY TO THE AMEND SECTION
2.100.020, "FEES ESTABLISHED".

WHEREAS, In order to comply with the Open Public records Act N.J.S.A. 47
1A-1 et seq., the City of Elizabeth is adopting the below changes to the fees charged for
copies of municipal records, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ELIZABETH:

SECTION 1. - That Section 2.100.020-Fees established is hereby amended to
read as follows:

The city is authorized to charge and collect fees for the sale of municipal records or
other documents as follows:

- A. Assessment Searches: Ten Dollars (\$10.00)
- B. City Map: Ninety Cents (\$0.90) Each
- C. Commissioners Map: One Dollar and Thirty-One Cents (\$1.31)
Per Sheet
- D. 11" x 17" Ledger Size Copies: Thirteen Cents (\$0.13) Per Sheet
- E. Flood Certificates: Five Dollars (\$5.00)
- F. CD/DVD: Two Dollars (\$2.00)
- G. Sewer Map: Ninety Cents (\$0.90) Per Sheet
- H. Tax Map: Sixty-Six Cents (\$0.66) Per Sheet
- I. Ward Map: Ninety Cents (\$0.90) Each
- J. All other Maps Larger than 11" x 17": Fifteen Cents
(\$0.15) Per Square Foot

SECTION 2. All ordinances or parts of ordinances inconsistent with the
provisions of this ordinance be and the same are hereby repealed.

SECTION 3. If any portion or clause of this ordinance is declared invalid for
any reason whatsoever, same shall not affect the validity or constitutionality of any other
part or portion of this ordinance.

SECTION 4. The effective date of this ordinance shall be twenty (20) days
after its final passage by City Council and approval by the Mayor at the time and in the
manner provided by law.
