

AN ORDINANCE TO AMEND CHAPTER 10.64.030 OF THE CODE OF THE CITY OF ELIZABETH ENTITLED "TAXI STANDS ESTABLISHED" SPECIFICALLY TO REPEAL: A. MORRIS AVENUE, 1. (COORDINATES); AND B. FIRST STREET, 1. (COORDINATES); AND TO ESTABLISH TAXI STANDS AT: NORTH AVENUE, ALONG THE SOUTHERLY CURB LINE, BEGINNING AT A POINT TWO-HUNDRED NINETY-FIVE (295) FEET WEST OF JEFFERSON AVENUE AND CONTINUING FOR THIRTY-FIVE (35) FEET WESTERLY THEREOF; ELMORA AVENUE, ALONG THE SOUTHERLY CURB LINE, BEGINNING AT A POINT TWO-HUNDRED (200) FEET EAST OF WEST GRAND STREET AND CONTINUING FOR THIRTY-FIVE (35) FEET EASTERLY THEREOF; BAYWAY, ALONG THE NORTHERLY CURB LINE, BEGINNING AT A POINT FIFTY (50) FEET EAST OF POLONIA AVENUE AND CONTINUING FOR THIRTY-FIVE (35) FEET EASTERLY THEREOF; AND ELIZABETH AVENUE, ALONG THE NORTHERLY CURB LINE, BEGINNING AT A POINT THIRTY-FIVE (35) FEET WEST OF SOUTH SECOND STREET AND CONTINUING FOR THIRTY-FIVE (35) FEET WESTERLY THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ELIZABETH:

SECTION 1. - That Chapter 10.64.030, "Taxi stands established" of the Code of the City of Elizabeth be amended to **REPEAL** the following:

- A. Morris Avenue
 - 1. (Coordinates)
- B. First Street
 - 1. (Coordinates)

SECTION 2. - That Chapter 10.64.030, "Taxi stands established" of the Code of the City of Elizabeth be amended to **ADD** the following:

- A. North Avenue.
 - 1. City Council of the City of Elizabeth establishes a taxicab stand as follows: along the southerly curb line of North Avenue, beginning at a point two-hundred ninety-five (295) feet west of Jefferson Avenue and continuing for thirty-five (35) feet westerly thereof.
 - 2. Remains the same.
- B. Elmora Avenue.
 - 1. City Council of the City of Elizabeth establishes a taxicab stand as follows: along the southerly curb line of Elmora Avenue, beginning at a point two-hundred (200) feet east of West Grand Street and continuing for thirty-five (35) feet easterly thereof.
 - 2. Remains the same.
- C. Bayway.
 - 1. City Council of the City of Elizabeth establishes a taxicab stand as follows: along the northerly curb line of Bayway, beginning at a point fifty (50) feet east of Polonia Avenue and continuing for thirty-five (35) feet easterly thereof.
 - 2. This taxicab stand is established with the stipulation that twenty-four (24) hour Service be available at all times and if such service is not afforded by the public, the establishment of this taxicab stand will be rescinded.

D. Elizabeth Avenue.

1. City Council of the City of Elizabeth establishes a taxicab stand as follows: along the northerly curb line Elizabeth Avenue, beginning at a point thirty-five (35) feet west of South Second Street and continuing for thirty-five (35) feet westerly thereof.

2. This taxicab stand is established with the stipulation that twenty-four (24) hour Service be available at all times and if such service is not afforded by the public, the establishment of this taxicab stand will be rescinded.


SECTION 3. - The administrative and enforcement aspects of this Ordinance shall be under the jurisdiction of the Police Department of the City of Elizabeth.

SECTION 4. - All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed.

SECTION 5. - If any portion or clause of this Ordinance is declared invalid for any reason whatsoever, same shall not affect the validity or constitutionality of any other part or portion of this Ordinance.




